**COVID-19** Please note! In case competition cannot be held due to conditions/restrictions caused by covid-19 we will notify all participating Clubs immediately. Participants are requested to follow the Finnish authorities instructions regarding travelling to Finland and quarantine requirements. If traveling to Finland requires quarantine prior to competition, please note that the competitor is responsible for all his/her expenses.

Santa Claus Competition will be conducted for invited clubs only in accordance with the ISU Constitution and General Regulations, the ISU Special Regulations for Figure Skating as well as all pertinent ISU Communications for Figure Skating and the regulations and classifications of the Finnish Skating Union.

### **Competition will be held for Novice girls and boys. Classes will be split categories in to age groups**

The Organizer has a right to split the categories into age groups, if the number of participants requires it.

| Novice B, Boys born 1.7.2005 or later, FS  | ISU evaluation |

**Entry** Entries must be submitted by using entry form which will be found on <https://www.varalatiimi.fi/kilpailut/santaclaus/entries> Entry form will be available starting from the **5th of October** 2020. Deadline for the entries is the **25<sup>th</sup> of October** 2020 at the latest. **Entries received after the deadline will be double fee.** Confirmation will be sent by 25<sup>th</sup> November 2020.

Please note that all clubs from outside Finland are guaranteed entry (COVID-19).

### Entry fee payment

The entry fees of foreign competitors can be paid by cash to the competition office during competitions before the start of the program at Tesoma Ice Stadium.  
For Finnish clubs entry fee invoice will be sent after competition (after medical certificates of cancelled skaters have been received)

### Cancellations

The Organizer has the right to send invoice for entry fee if participation is cancelled after **21<sup>st</sup> of November** 2020 without a medical certificate. A medical certificate has to be sent latest one week after competition (11<sup>st</sup> December 2020).

### Draw

The draw will be on Sunday, **22<sup>nd</sup> of November** 2020. The final schedule with details and starting orders will be placed on the competition website by the 23rd of November 2020. Warm up groups will be confirmed on Thursday 3<sup>rd</sup> of December.
