



# Announcement of Hyvinkää Trophy 2018

Figure Skating Club Hyvinkään Taitoluistelijat ry, Finland, has a pleasure to invite skaters to participate in the competition of Hyvinkää Trophy 2018.

Competition will be held in the following Single Skating categories and classes

### ISU evaluation:

Junior B, Ladies FS (Juniorit) born 1.7.1998-30.6.2004
Junior C, Ladies (Aluejuniorit) born 1998 or later
Novice B, Girls (Noviisit) born 1.7.2002 or later
Novice C, Girls (Aluenoviisit) born 2003 or later
Springs A, Girls (Silmut A) born 2006 or later

## Finnish star evaluation:

Springs B, Girls (Silmut B) born 2006 or later Springs B, Boys born 2006 or later Springs C, Girls (Aluesilmut) born 2006 or later **Springs C, Boys** born 2006 or later Cubs, Girls (Minit) born 2008 or later Cubs, Boys born 2008 or later Pre-Young I, Girls (Taitajat) born 2000-2005 Pre- Young I, Girls born 2006 or later Pre-Young II, Girls (Taitajat, Axel) born 2001 or later

Chicks, Girls and Boys(Tintit) born 2009

Pre-Chicks Girls and Boys (Tintit) born 2010 and younger

The organizer has the right to change the categories if the number of participants requires it.

**Judging:** In the Finnish star evaluation system skaters will be judged by giving stars from different

technical elements and presentation components. In other classes skaters are judged by using the ISU judging system. The organizer will invite the judges and pay their expenses.

# **Preliminary Competition Schedule:**

Saturday 20.1.2018 at 8.00 - 21.00 and Sunday 21.1.2018 at 8.00 - 21.00.

Organizing club reserves the right to change the schedule. More detailed schedule will be published on the official web site by January 2, 2018.

## Registration of entries:

Entries must be submitted by December 28, 2017 at the latest using the entry form (all categories). Please email entries to the following address: kilpailut.hvtl@luukku.com.

Competitors must be members of an association or a club with the ISU. Organizing club reserves the right to enter more competitors and limit the number of skaters. Confirmation of the skaters accepted to the competition and preliminary competition schedule will be published on the web site by January 2, 2018.

In a case a skater has been entered in the competition but cannot participate, she/he can be replaced by another skater in the same category between closing date of entries to 24 hours before the draw. Participating clubs are asked to immediately inform of any changes in their entries by emailing kilpailut.hytl@luukku.com.

## Planned program content:

Please send the Planned Program Components for ISU category entries by email to kilpailut.hytl@luukku.com no later than 8.1.2018.

Entry Fee: Entry fees and judges' expenses are invoiced after competition. Entry fees are as follows:

Star evaluation:

Chicks 15€ for each skater.

Other star evaluation 25€ for each skater.

ISU evaluation: Springs A, Novice C and Junior C 40 € for each skater.

ISU evaluation: Novice B, Junior B 45 € for each skater.

Please note that entry fees are refunded only against medical certificate.

### **Cancellations:**

After **4.1.2018** only cancellations supported with a medical certificate will be refunded. Participating teams should inform of any changes in their team as soon as possible to kilpailut.hytl@luukku.com.

The official draw will be held at Hyvinkää ice rink on Thursday, 4.1.2018 at 17.30. The Draw:

result will be published on the official web site of the competition on 5.1.2018.

Music will be played on CD player. Music must be provided on CD (no CD-RWs or DVDs). Music: CDs equipped with the full name of the competitor, category and the name of the club must be submitted to the organizer's desk before the relevant event and picked up from the same place after event. All competitors must have an extra copy of their music available at

rink side during their event.

**Awards:** Three first standings will be awarded with a cup and diploma. All other competitors

will receive a diploma at the awarding ceremony.

Liability: According to the ISU Regulations, Rule 119, the organizer accepts no responsibility or

liability with respect to bodily or personal injury, property loss or damage suffered by the

competitors or officials during the competition.

Participants are expected to have their own insurance. Such insurance must assure adequate medical coverage and also the return to the home country by air transport or by

other expeditious means of the ill or injured person.

**Results:** Result information and detailed protocols will be available on the official web page of the

competition.

#### **Protests:**

Each team has the right to submit protest against the judges' decision. Protests must be submitted to the Referee of the relevant event at the latest 30 minutes after the category. Upon the submission of the protest a protest fee of 30 EUR must be paid. The referee's decision is final. In the new ISU Judging Systems no protests can be filed against the judges, but against the right determination of the executed element or any calculation error.

# Accommodation and expenses:

All participants pay the accommodation and other expenses by themselves.
