Figure Skating Club Hyvinkään Taitolustelijat ry, Finland, has the pleasure to invite skaters to participate in the competition of **Hyvinkää Trophy 2019.**

Event time: 2-3rd February 2019, Hyvinkää, Finland

Organizer: Hyvinkään Taitoluistelijat ry (www.hytl.fi)

Venue of the competition: Hyvinkää Ice Rink, Vaiveronkatu 70, Hyvinkää, Finland

Competition will be held in the following Single Skating categories and classes.

ISU evaluation:

Junior B, Ladies FS born 1.7.1999-30.6.2005
Junior C, Ladies born 1.7.1999 or later
Novice B, Girls born 1.7.2003 or later
Novice C, Girls born 1.7.2003 or later
Springs A, Girls born 2007 or later

Finnish star evaluation:

Debutants C, Girls born 1.7.2005 or later Springs B, Girls and Boys born 2007 or later born 2007 or later born 2009 or later born 2009 or later born 1999-2006 born 2007 or later Pre-Young I, Girls born 2007 or later born 1999 or later born 1999 or later

The organizer has the right to change the categories if the number of participants requires it.

Judging: In the Finnish Star evaluation system skaters will be judged by giving stars from

different technical elements and presentation components. In other categories, skaters are judged by using the ISU judging system. The organizer will invite the

judges and pay their expenses.

Preliminary Competition Schedule:

Saturday 2nd **February 2019 at 8.00-21.00 and Sunday, 3**rd **February 2019 at 8.00-21.00.** Organizing club reserves the right to change the schedule. More detailed schedule will be published on the official web site by 7th January 2019.

Registration of entries:

Entries must be submitted by 28th December 2018 at the latest using the entry form (all categories). Please email entries to the following address: hyvinkaatrophy@gmail.com

Competitors must be members of an association or a club with the ISU. Organizing club reserves the right to enter more competitors and limit the number of skaters. Confirmation of the skaters accepted to the competition and preliminary competition schedule will be published on the web site by 7th January 2019.

In a case a skater has been entered in the competition, but cannot participate, she/he can be replaced by another skater in the same category between closing date of entries to 24 hours before the draw. Participating clubs are asked to immediately inform of any changes in their entries by email: hyvinkaatrophy@gmail.com

Planned program content:

Please send the Planned Program Components for ISU category entries by email to hyvinkaatrophy@gmail.com no later than 14th January 2019.

Entry Fee:

Entry fees and judges' expenses are invoiced after competition.

Entry fees are as follows:

<u>Finnish Star evaluation:</u> Chicks 15€ for each skater

Other star evaluation 25€ for each skater

ISU evaluation:

Springs A 40€ for each skater Novice C and Junior C 40€ for each skater Novice B and Junior B 45€ for each skater

Please note that entry fees are refunded only against medical certificate.

Cancellation:

After 9.1.2019 only cancellations supported with a medical certificate will be refunded. Participating clubs should inform of any changes in their team as soon as possible to hyvinkaatrophy@gmail.com

Draw:

The official draw will be held at Hyvinkää ice rink on 9th January 2019 at 17.30. The result will be published on the official web page of the competition on 10th January 2019.

Music:

Music will be played on CD player. Music must be provided on CD-R (no CD-RWs or DVDs). CDs equipped with the full name of the competitor, category and the name of the club must be submitted to the organizer's info desk before the relevant event and picked up from the same place after event. All competitors must have an extra copy of their music available at rink side during their event.

Awards: Three first standings will be awarded with a cup and a diploma. All other competitors

will receive a diploma at the awarding ceremony.

Liability: According to the ISU Regulation, Rule 119, the organizer accepts no responsibility

or liability with respect to bodily or personal injury, property loss or damage suffered

by the competitors or officials during the competition.

Participants are expected to have their own insurance. Such insurance must assure adequate medical coverage and also the return to the home country by air transport

or by other expeditions means of the ill or injured person.

Results: Result information and detailed protocols will be available on the official web site of

the competition.

Protests: Each team has the right to submit protest against the judges' decision. Protests

must be submitted to the Referee of the relevant event at the latest 30 minutes after the category. Upon the submission of the protest a protest fee of 30€ must be paid. The referee's decision is final. In the new ISU Judging Systems no protests can be filed against the judges, but against the right determination of the executed element

or any calculation error.

Accommodation and expenses:

All participants pay the accommodation and other expenses by themselves. Please make the reservations directly with the hotel. See offers of accommodation at the competition's web page.
