| Assistive devices, support insoles, occlusal splints, etc. | Max. €400/calendar year | Have a prescription from a doctor or occupational physiotherapist. The same assistive device is replaced every 2 years at the earliest. You have to pay for it yourself in full first. |
| Treatment provided by a physiotherapist, trained masseur, chiropractor, naprat or osteopath (No doctor's prescription required!) | Max. 600 e/calendar year | The treatment provider must be in Valvira's register! The treatment must be in question. industry. NO DOCTOR'S PRESCRIPTION REQUIRED! THE CLARIFICATION FORM MUST BE FILLED IN BY THE TREATMENT PROVIDER! You have to pay for it yourself in full first. |
| Dental care (after one year of insurance relationship!) | Max. 800 e/calendar year | NOTE Term: 1 year insurance relationship before the day of treatment NOTE!! You have to pay for it yourself in full first. By showing your membership card, you can get discounts from partners!*) |
| Public health care fees (not including dental care) | | Hospitalization days max 60/cal.year. You have to pay for it yourself in full first. |
| Institutional and procedure fees | Max. €400/calendar year | No loyalty, office fees, etc. You have to pay for it yourself in full first. |
| Surgeries, private sector | Max. €400/calendar year | Does not apply to surgery to correct vision! You have to pay for it yourself in full first. |
| Medicines (SVL-reimbursable medicine) | | Must have a doctor's prescription. From contract pharmacies*) you can get the medicines with only a deductible by showing your membership card. |
| Medicines (not reimbursable by SVL) | Max. €400/calendar year | Must have a doctor's prescription. A medicine in Kela's pharmaceutical database. You have to pay for it yourself in full first. |
| Doctor's fees (single health care) | Max. 800 e/calendar year | In contract companies*), you can get discounts and doctor's fees with only a deductible on the invoice by showing your membership card. |
| Optician fees | Max. €100/calendar year | You have to pay for it yourself in full first. |
| Injections, at the doctor's office | Max. €400/calendar year | You have to pay for it yourself in full first. |
| Vaccinations | Max. €100/calendar year | You have to pay for it yourself in full first. |
| Nurse's fees | Max. €400/calendar year | You have to pay for it yourself in full first. |
| Glasses/contact lenses (after one year of insurance!) | The first compensation max. 350 e, late purchases max. €350 / €525 / €700 (depending on the time of purchase at intervals of 2 - 4 years and insurance premium periods) | N.B! Term: 1 year insurance relationship before the date of purchase. Higher claims (not applicable to the 1st purchase) require an uninterrupted premium history. You have to pay for it yourself in full first. By showing your membership card, you can get discounts from partners!*) |
| Examinations with a doctor's prescription in the private sector | Max. 800 e/calendar year | Must have a doctor's prescription. In contract companies*), you can get discounts and some treatments with a deductible only by showing your membership card on the invoice. |
| Examinations without a doctor's prescription in the private sector | Max. 100 e/cal. year (this consumes the maximum ear cap of the task by doctor's order) | However, examinations with or without a doctor's referral are reimbursed for a maximum of a total 800 euros/year. You have to pay for it yourself in full first. |
| Deductible for private medical expenses insurance | Max. €400/calendar year | If the cost would have been compensable according to the fund's rules. You have to pay for it yourself in full first. |

Benefits are paid up to €5000 per calendar year per insured person. The above amount does not include medical expenses.

Treatment provided abroad is not reimbursed.

The application period for compensation is six (6) months.
