LCIF Refugee Assistance Grant Application and Guidelines

LCIF has made an appeal for donations to the **LCIF Refugee and Displaced Persons Fund** to support “Ukrainian Refugee and Displaced Persons Relief.” This ongoing refugee crisis has seen 7.6 million people fleeing Ukraine and an estimated 8 million displaced within the country, resulting in enormous needs. LCIF intends to aid Lions Districts involved in service to meet the needs of refugees through four main areas, immediate needs, transitional needs, Integration support, and reconstruction.

Who can apply for funding?

LCIF Districts are eligible to apply to LCIF. Clubs interested in LCIF grant funding should contact their District Governor for support and endorsement of their project. As LCIF is only awarding districts one grant at a time, it might be good to coordinate efforts with other clubs in your district to allow for maximum impact. Undistricted areas with 100+ refugees are also eligible. Projects must be endorsed by the highest-ranking Chairperson in your region, either the Zone Chairperson or the Region Chairperson, and the area's Coordinating Lion.

What can the grant funds support?

Immediate Needs

Districts with 100+ refugees are eligible to request grants of US\$20,000 for a Lions-led hands-on relief project to distribute food, clothing, blankets, hygiene supplies, and medicines. The Lions should limit costs associated with housing, such as rent and deposits, to three months. Funds cannot be given as cash or voucher handouts. All grants will be awarded at the district level.

Transitional Needs

Districts with 100+ refugees are eligible to request grants starting at US\$20,000 for Lions-led hands-on projects to help refugees transition into life in their host country. The expectation is that the refugees will settle for a minimum of nine months, and there is a plan for what to do with the purchased items if they unexpectedly return to their home country or move to another country. Eligible expenses include:

- Furnishing homes for refugees.
- Purchasing bicycles to allow transportation to and from work or school.
- School supplies and sports equipment for children.

Integration Support

Districts with 100+ refugees can apply for grants for a minimum of US\$20,000 to help support projects and programs to integrate refugees into the community. Project ideas include but are not limited to

adult language classes, vocational training, group therapy, and Lions Quest training for Ukrainian teachers or teachers who will welcome large numbers of Ukrainians into their classrooms.

Reconstruction

After the conflict ends, LCIF will consider reconstruction projects. Such reconstruction will have a priority focus on public institutions and housing for vulnerable populations, such as the elderly and the disabled.

Criteria and Regulations

- Transitional Needs, Integration Support, and Reconstruction projects have a minimum request amount of US\$20,000. While there is no maximum request amount, staff may request that the Lions reduce the scope of their project if it is determined they can do the project more cost-effectively to allow more districts opportunities for funding.
 - LCIF-funded projects ideally help large groups of people and are not available for projects helping individuals, individual families, or small groups.
 - A final report detailing the expenses and activities of the project is required before any additional LCIF Refugee Assistance grants can be awarded to the District/Undistricted area. Failure to submit a final report could affect the District's ability to request other LCIF grant programs, such as the Emergency grant or the Matching grant.
 - Lions may not hand over grant funds to another organization or the government.
 - Lions and/or their families should not receive direct or professional benefit or have proprietary interest in projects receiving LCIF assistance.
 - All projects must take place within the applicant's district.

What is the process to apply?

Lions should assess the local situation to determine the need and the best way Lions can make the lives of refugees easier. In some countries or areas, the state controls the care of refugees. Contacting and working alongside established refugee organizations and local government can help to gain permission and access to refugee populations. Working with established NGOs also can help to reduce duplication of efforts. LCIF expects to see a clear and concise action plan and will not fund unclear or vague project ideas. Please answer the following questions about the project.

Rovaniemi ja Kemi
7. What is the current situation for refugees in the project's target area?
Vuoden 2024 aikana Rovaniemelle on tullut 350 ja Kemiin 100 uutta ukrainalaispakolaista. Suomessa olevat ukrainalaiset saavat valtioilta pieniä taloudellisia tuen, joka ei riitä päivittäiseen toimeentuloon. Ukrainalaispakolaisten työttömyysaste on korkea.
8. What type of help do the Lions plan to provide: Immediate needs/Transitional Needs/Integration Support/Reconstruction: Kesän ja syksyn aikana 2024 Rovaniemelle ja Kemiin tulleilla ukrainalaispakolaisille on suuri välittömän/pikaisen tuen tarve. Alkuvuonna 2024 Rovaniemelle tulleilla ukrainalaisilla on suurin tarve siirtymävaiheen ja integraatiovaiheen tuesta.
9. What is the project plan? Please explain what will be done, how the Lions will distribute the goods, how Lions will deliver the services, how Lions will identify the beneficiaries and the role of any partners:
Kesän ja syksyn 2024 aikana Rovaniemelle ja Kemiin saapuneet ukrainalaiset tarvitsevat kipeimmin hygieniarvikkeita, vuodevaatteita sekä talvivaatteita ja -kenkiä. Rovaniemi ja Kemi sijaitsevat arktisella alueella ja arktinen talvi on monelle uudelle ukrainalaispakolaiselle ennen kokematon asia. Rovaniemellä ja Kemissä muutaman kuukauden olleet ukrainalaiset tarvitsevat astioita, kodinkoneita (mm. vedenkeitimiä, vatkaimia ja mikroaaltonuneja) ja kodinkalustetta sekä tukea kielipintoihin ja ammatilliseen koulutukseen. Monet Rovaniemellä ja Kemissä olevat ukrainalaiset tarvitsevat traumataustansa vuoksi terapeuttista tukea.

Lionit hankkivat LCIF:n apurahalla välittömän/pikaisen tuen tarpeessa oleville ukrainalaisille hygieniarvikkeita, vuodevaatteita sekä talvivaatteita ja -kenkiä. Siirtymävaiheen tuen tarpeessa oleville ukrainalaisille hankitaan astioita sekä kodinkoneita ja -kalustetta. Intergraatiovaiheessa olevien ukrainalaisten kielipintoja, koulunkäyntiä, ammatillista koulutusta ja terapien saamista tuetaan hankkimalla ukrainalaispakolaisten yhteiskäyttöön pakolaiskeskuksiin sijoitettavia kannettavia tietokoneita (30 kpl). Kannettavat tietokoneet mahdollistavat opiskelun ja terapien etäyhteyksin, mikä on erityisen tärkeää Lapissa, missä välimatkat ovat pitkät ja matkustaminen kallista.

Hankimme hygieniautotteet, vuodevaatteet, talvivaatteet ja -kengät, astiat, kodinkoneet ja -kalusteet sekä kannettavat tietokoneet piirin alueella toimivilta luottavilta tavarantoimittajilta. Hankimme kannettavat tietokoneet ukrainalaisten yhteiskäyttöön. Henkilökohtaiseen käytöön tarkoitettut tavarat luovutamme lionsklubien avustuksella pakolaiskeskusten kautta ukrainalaisille ja yhteiskäyttöön hankittavat tietokoneet toimitamme pakolaiskeskusten hallinnoimiin ja valvomiin yhteiskäyttötiloihin. Lionit seuraavat yhteiskäyttöön luovutettavien ja pidemmän käyttöiän omaavien esineiden käyttöä. Jos ukrainalaiset poistuvat piirin alueelta, kannettavat tietokoneet ja muut pitemmän käyttöiän omaavat esineet jäävät pakolaiskeskuksiin muista maista tulleiden pakolaisten käyttöön tai ne luovutetaan sosiaalisin perustein paikallisten vähävaraisten perheiden käyttöön.

Ennen tavaroiden hankkimista selvitämme pakolaiskeskuksista ukrainalaisten hakintajankohdan tarpeet ja päätämme hankintojen tarkan sisällön ajantasaisen tiedon perusteella.

Projekti on tarkoitus hoitaa loppuun maaliskuun 2025 loppuun mennessä.
