Our area offers services for self-driving and nature-loving caravanners:

- Water points, dishwashing facilities
- Electricity
- Chemical toilet waste disposal, toilets, bio-toilets
- Sauna and shower, swimming in lake, piers, rowing boat and life jackets
- Grill hut & firewood. Facilities include a fridge, microwave, coffee maker and kettle and hotplate. Please note that *open fires* may only be used in the grill hut.

Fees – motorhomes, campers and tents

The daily fee includes electricity. No additional charges per person. Every 5th consecutive day is free of charge. For electric car charging, see other fees.	The daily fee includes electricity. - The accommodation period ends at 3 pm (15.00).
- Electric and gas grills are permitted. Charcoal grills and open fires are not allowed due to safety.
- Children must be under the supervision and responsibility of their guardians while in the area.
- We want to keep the area quiet at night between 11 pm and 7 am (23.00-7.00).
- Pets are welcome.

Other fees

Private sauna, 1 h, on request: SFC member 15 €/h and non-member 20 €/h.
LPG: Ask for the current price.
Charging an electric car with a meter according to consumption 0,30 €/KWh.

Includes VAT on accommodation 13.5 % and other services 10 %.

Payments are made by card during the host on duty hours. At other times, payments are made to the Association's account within seven days. **No cash payment.**

During the host on duty days, please return the **completed passenger declaration** form to the host. The passenger form must be filled out as in hotels, as required by law.

When the area is a self-service area:

- Fill in the passenger declaration and enter the date of arrival and departure in the declaration.
- Fill in the bank transfer form, one part for yourself and one part for the association.
- Always leave the above documents in the grey mailbox inside the open office. Thank you!

Host on duty during the summer season 2026

The host on duty is available daily from 1 June to 1 September, and on weekends in September. Outside host hours, the area operates as a self-service area.

During the summer, a host is on duty to meet visitors and, if necessary, other permanent place holders help. Host duty is a rotating assignment in the area. The host on duty is responsible for guiding, charging visiting fees, heating the sauna and cleaning.

Sauna & shower

The fee includes the use of the sauna on public sauna days. Every day in summer. Sauna shifts are during the host on duty times are:

- Women 6 pm - 7.30 pm (18.00 - 19.30)
- Men 7.30 pm - 9 pm (19.30 - 21.00)

The private sauna, 1 hour per time, can be reserved two hours before or after the public sauna times. See the pricelist, other fees.

The shower can also be used outside of sauna times. When using the shower, you can place the "Reserved" sign (Varattu in Finnish), which can be found hanging in the corner, in front of the terrace. The host usually heats the water in the morning, but you can light the stove if needed. Heating takes time, so please be patient.

Outside of host shifts, the area is a self-service area, and the sauna and shower water are heated as required.

Safety

When camping, you must maintain a **minimum safety distance of four (4) meters** from another caravan, motorhome, awning, tent, terrace or similar. The safety distance must be at least 4 meters from:

- Another camper or motorhome
- Another awning / tent
- Another wooden laver or fence attached to a caravan place
- A separate tent
- A towing motorhome
- A towing vehicle not associated with the fire load unit in question.

Parking

Park your camper or motorhome in a marked place either:

- The left rear corner is at the place marker.
- If the front is ahead, park the vehicle 4 m to the left of the sign, leaving the necessary safety clearance for the next vehicle.
